Petitions and Public Questions – Full Council (13 March 2024)

Item 2(a) Petitions

- (a) Councillor A Carr to present a petition on behalf of residents requesting the Council do all it can to ensure that the No 1 and 2 bus service are not withdrawn from use.

(a) Paul Bartlett to Councillor Wilson-Marklew (01/03/24 – 23:46)

“Residents of Stony Stratford and Milton Keynes, including Councillors at all levels, who seek repairs to streetlights, pavements and similar do not expect to receive notices from your office stating that works have been completed when they have not, thus can you explain why this is often the case and investigate why your departments are giving false information?”

(b) Paul Ridley to Councillor Darlington (07/03/24 – 11:44)

“Tuesday April 2nd is world autism day, this falls during autism week and I wonder if the Council will be supporting this or indeed taking part in the 5k walk during world Autism Acceptance week. I know that the election period starts next month for the local elections so could the council confirm they will be supporting World autism awareness week & World Autism day on April 2nd?”

(c) Don Hoyle to Councillor Wilson-Marklew (10/03/24 – 19:23)

“The last meeting of the Public Realm and Environment Scrutiny Committee discussed flooding and how to reduce the effects of flooding with water management. Rather than collect all this water, Anglian Water are installing smart water meters, which can disaggregate, or reduce, the flow of water to each household. So, my question is: can you assure residents that the council will press Anglian Water, as a matter of some urgency, to increase water storage and thus supply all the water we want, rather than ration it?”

(d) Christine Griffiths to Councillor Mahendran (11/03/24 – 10:05)

“Has Milton Keynes City Council made the residents aware of Project Skyway (by Altitude Angel) a 165 miles (265km) Drone Superhighway connecting airspace above Reading, Oxford, Milton Keynes, Cambridge, Coventry, and Rugby. I personally have not seen any communication from the Council. I would like to ask if risk assessments have been put in place for this project? I am very concerned about wildlife (particularly birds), noise pollution and privacy issues and will be looking into this further.”
