1	Bring forward a robust and balanced budget	The 2022/23 outturn delivered within approved overall budget. Financial training delivered to the Budget and Resources Scrutiny Committee on 15 June.
		Finance colleagues, working with the Corporate Leadership Team (CLT) have presented a balance draft budget to Cabinet on 19 December 2023 which is currently out for public consultation. A clear approach to savings has been set out, with detailed work underway to address budget pressures anticipated in 2025/26 and beyond.
		Substantial budget pressures and risks, as seen in most other parts of local government, remain a cause for concern. Very close attention is being paid to budget management across the organisation in the context of a mid-year overspend.
		Finance colleagues have been actively engaged with government on Housing Revenue Account (HRA) financial sustainability to raise awareness of some of the challenges and sustainability issues in the HRA. Draft HRA budget is balanced for 2024/25 and the gap has been reduced significantly in future years, with a review of capital investment planned in the first quarter of 2024.
		Final budget published for 6 February Cabinet delivers a balanced and robust budget for 2024/25.
2	Implement innovative recruitment and training initiatives, especially in relation to hard to fill roles like lawyers,	The first cohort of the Planning Academy has seen five graduates work across a selection of our teams whilst they undertake post-graduate professional qualifications in town planning. Recruitment for the second cohort has been completed with two preferred candidates employed.

		To date we have appointed and are progressing 18 apprentice social work roles in children's services who are currently progressing across four cohorts, for whom we have a rolling programme. This allows us to grow and retrain our own workforce.

		Cabinet and Special Council decsisions were taken in December, which approved the appointment of the preferred contractor and extra borrowing to deliver this key regeneration project, considering the final cost and budget requirements, as well taking into account the Homes England grant.
		The main works contract was executed in December, ready for the main works to commence by February. Early site preparation commenced in December.
