## **CL1 Election of Mayor**

It was moved by Councillor Nolan and seconded by Councillor R Bradburn that Councillor Mick Legg be elected Mayor of Milton Keynes for the Council Year 2023/24.

Other councillors spoke in support of the nomination.

Councillor Legg signed the Declaration of Acceptance of Office.

The Mayor, on accepting the office of Mayor, welcomed all those in attendance and thanked the Council for bestowing him with this highest of honours. The Mayor noted that he was first elected in 1996 and was proud to have grown up in Milton Keynes and to have been witness to all the landmark achievements that had happened so far. The Mayor advised that his wife, Mandy Legg, would be the Mayoress.

The Mayor referred to the fact that they would be a different kind of Mayor and Mayoress given that he would be the first full time working Mayor but that he hoped this precedent would inspire others that having a day job would not preclude you from being the first citizen of Milton Keynes.

The Mayor noted that he would be changing a recent precedent and that he would not be abstaining from voting.

The Mayor noted that his theme for the year would be health and wellbeing and that his chosen charities were Harry's Rainbow and SOFEA.

The Mayor summed up by thanking his family for encouraging and supporting him, his Labour colleagues and his employer for allowing a degree of flexibility to allow him to undertake the role.

Amanda Marlow noted that this had been an incredible year to be Mayor, from the award of city status, Platinum Jubilee celebrations, the death of Her Majesty Queen Elizabeth the Second, the Women's Euros, a royal visit, civic reception and coronation of King Charles the Second. These events had showcased the diverse groups and organisations in our city.

Amanda Marlow noted that civic fundraising for her charities MK Snap and Medical Detection Dogs had raised £9,288.

Amanda Marlow thanked Councillor McLean for encouraging her to stand for Mayor, Catriona Morris for her support during the year along with her Conservative colleagues and officers for their support, including staff in Democratic Services and in particular: Angie Deacon; Siobhan Pitkin; and David Broom.

Amanda Marlow concluded by thanking her family for their support, in particular her Consort, and noted that this year had been life changing and a role of a lifetime. She was very proud to have served Milton Keynes as Mayor over the last twelve months.

That, in accordance with the Local Government and Housing Act 1989 and the Local Government (Committees and Political Groups) Regulations 1990, the Council note that the Conservative Group is entitled to 30.16% of the seats on the Council's Committees, the Labour Group is entitled to 43.65% of the seats and the Liberal Democrat Group is entitled to 26.19% of the seats on the Council.
